# 1 OVERVIEW

The 2018/2019 Trilingual branch of CIFE's Master in Advanced and International Studies was composed of a diverse group of 12 students from 9 different nationalities. The itinerant programme offered students intensive courses in Nice, Canterbury and Berlin over three terms extending from 9 October 2018 to 9 July 2019. Afterwards, students were given the option of continuing their training with an internship of 3 to 6 months with a compulsory report upon completion. In Nice, the students were given an overview of the construction and the internal decision-making dynamics of the European Union, as well as introductory courses to Economics, International Relations and Federalism. At the end of the trimester, the students participated in a simulation game of the European Council organised in the framework of the HORIZON 2020 Project FEUTURE.

In Canterbury, students were then afforded the opportunity to choose their area of interest amongst the study offerings at the University of Kent in their International Relations department.

Then in Berlin, the students had the opportunity to further develop what had been started in Nice while also delving further into today's EU challenges, including migration, EU enlargement, Eurozone, etc. As the programme is trilingual by nature, all classes were conducted in either English, French or German.

After the last trimester in Berlin, the students were occupied with the writing of their Master's theses, after which some students made the choice to further their training with an internship.

Upon completion of all academic requirements, the students were granted with 60 ECTS credits (90 ECTS with the internship option) under the European Qualifications Frameworks (EQF). In addition to the Master diploma, the students also received the degree qualification "Chargé de Mission en Organisations Européennes et Internationales" (Policy Officer in European and International Organisations). This qualification is registered in the French national register of professional qualifications (RNCP) and recognised as a degree at Master level (level 7 of the EQF).

At the end of this trimester, students were required to then sit end-of-term oral examinations on the modules studied.





## CANTERBURY

In Canterbury, the students are enrolled at one of CIFE's most renowned partners, the University of Kent. Having registered online from Nice for the Spring Term at the University of Kent, the students were allowed to choose and register for classes in three different modules that kept them busy throughout the entire term. Here the students were integrated into the University of Kent as regular students and were thus required to respect all of the University's rules, such as regular attendance in classes. At the end of the term, the grades received by the students in these modules were then integrated into the CIFE's grading system. The modules taken by the students were the following:

During this period, the students also had access to the university's well-equipped library, where they had the opportunity to advance in their research work or thesis writing.

## STUDY TRIP TO THE EUROPEAN INSTITUTIONS

From 10 March 2019 to 15 March 2019, the students were excused from their academic responsibilities at the University of Kent. The group travelled to Strasbourg to start their 5-day study trip to the European Institutions. During this period, they visited the following establishments:

During the organised tours of these institutions, representatives briefed the students about their role and structure. Students had a glimpse of the working environment surrounding these important institutions and were able to network with former CIFE students working there as well. Different questions were posed by students, as they sought to find out what studies the different representatives undertook and their professional experience before arriving at the various institutions in their present roles. At the end of the study trip, the students flew back to Canterbury to finish their trimester at the University of Kent.



## BERLIN

During their last trimester in Berlin, the students lived together at the Studentendorf Schlachtensee complex, where classes were also habitually held. In the German capital, the partnership with the Institut für Europäische Politik allowed a smooth running of the programme. In fact, besides other institutional visits, the students had the privileged access to the University Library of Humboldt-Universität zu Berlin and to the Staatsbibliothek zu Berlin, which facilitated the research and study work characterising this last trimester. ## → Conferences

During the month of June, a week-long seminar was held during which the students were introduced to the way Germany's government has adapted itself to European politics and the different offices and institutions within Germany's political system that interact directly with the EU. They were told about the everyday functioning of each of the institutions and offices visited and also attended different conferences on related topics.

Written exams on International Relations, European Integration, Federalism & Governance, and Economy & Globalisation modules were scheduled towards the end of this term. Furthermore, the Grand Oral scheduled on 8 July 2019 ended this year's round of compulsory exams required before the students' submissions of their theses.

## INTERNSHIP AND GRADUATION

The first group of students submitted the final version of their thesis by 2 July 2019 and the second group on 1 September 2019. The students were then scheduled on different dates to defend their ideas, which represented the very last academic requirement of their academic year with CIFE. After the end of the term in Berlin, 8 students followed on with an internship (of minimum 3 months and maximum 6 months). While CIFE did indeed propose some internship offers to students, it was at the discretion of the students to freely choose the internship that best suited his or her interests.

After an entire year of research and practical work, CIFE awarded the students of the Trilingual branch 2018/2019 with the Master diploma and the Policy Officer Qualification degree, during the graduation ceremony held in Berlin on 9 July 2019.
